Part 1 International Cities of Peace

1. Induction and training

• To provide thorough induction on the work of *International Cities of Peace*, its staff, your volunteering role and the training necessary to assist you in meeting the responsibilities of your volunteering role, The Volunteers Handbook provides full details of the organisation.

2. Supervision, support and flexibility

- To define appropriate standards of our services, to communicate them to you, and to encourage and support you to achieve and maintain them as part of your voluntary work
- To provide a personal supervisor who will meet with you regularly to discuss your volunteering and any associated problems
- To do our best to help you develop your volunteering role with us and to be flexible in how we use your volunteering.

3. Expenses

- To reduce the costs of operating the non-profit corporation Cities of Peace Inc., especially the main platform International Cities of Peace, volunteer activities are primarily performed through online resources, such as email, video sessions, web or social media involvement, or through open source software, and other commonly held tools and resources.
- If expenses could be accrued during the performance of your duties, please contact -- prior to accruing the expenses -- the Chair of Cities of Peace, Inc. or the Executive Director of International Cities of Peace to receive a decision on your request.
- Unless expressly detailed in a contractual document, signed by the Chair of Cities of Peace, Inc. or the Executive Director of International Cities of Peace, expenses will not be compensated.

4. Health and safety

• To provide adequate training and feedback in support of our health and safety policy, a copy of which is in the Volunteers Handbook.

6. Equal opportunities

• To ensure that all volunteers are dealt with in accordance with our equal opportunities policy, a copy of which is set out in the Volunteers Handbook.

7. Problems

- To endeavour to resolve in a fair and just manner any problems, grievances or difficulties which may be encountered while you volunteer with us;
- In the event of an unresolved problem, to offer an opportunity to discuss the issues in accordance with the procedures set out in the Volunteers Handbook.
